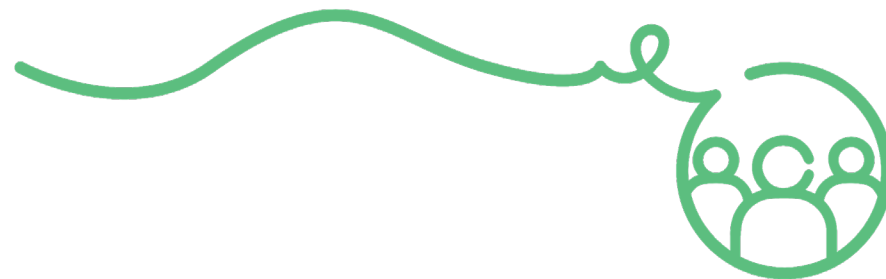

 ACT Public Holidays

 Return & Payment due date

Lodging quarterly returns

- ✓ Ordinary gross wages* are wages before tax is deducted.
- ✓ Wages to be entered for all employees that perform relevant work in the ACT only.
- ✓ If an employee has stopped working for you, include their cease date.
- ✓ Avoid penalties—lodge and pay by the due date or request an extension of time.

Paid days include

- ✓ Days worked
- ✓ Shift/weekend work
- ✓ Annual leave
- ✓ Sick leave
- ✓ Public holidays
- ✓ Workers' compensation
- ✓ Above award payments

Paid days do not include

- ✗ Meal/clothing allowance
- ✗ Overtime
- ✗ Travel allowance
- ✗ On call allowance
- ✗ Annual leave loading
- ✗ Work outside the ACT
- ✗ Annual leave paid on termination

Employees to include

- ✓ Advocacy care workers
- ✓ Aged care, childcare, disability workers and teachers who perform education and care services
- ✓ Care home employees (excluding medical)
- ✓ Casual, part-time, full-time employees

Employees not to include

- ✗ Working Directors
- ✗ Sub-contractors
